M. James reported that Education Code 28.004 requires a school district to post on its website the following:

Physical Activity Policies (Education Code, §28.004(k))

Requires a school district to post on its website a statement of its physical activity policies for elementary, middle school, and junior high school students and statement of the number of times during the preceding year the health advisory council met, whether the district has adopted and enforces policies to ensure that campuses are complying with vending machine and food service guidelines, whether the district has adopted and enforces policies that penalize the use of tobacco products by students, and a statement providing notice to parents that they can request in writing their child's physical fitness assessment results at the end of the school year.

Tobacco Policy- Our Student Code of Conduct indicates that the following offense is considered a Level 3 offense: Possession of, selling, or using tobacco products, including but not limited to cigarettes, vapor cigarettes, electronic cigarettes (including any component, part, or accessory for an e-cigarette device), cigars, pipes, snuff, or chewing tobacco. This is also included in transportation policies. Level 3 violations often result in ISS assignments, but can also be addressed through discretionary DAEP assignments.
