Child Nutrition Updates- M. James for R. Arthur

Rachel is happy to report that the PE teachers will receive a 1/2 day training from a CATCH trainer at the upcoming PD day. Also, Child Nutrition is bringing FoodPlay to our district. We are spending about 12,000\$ to be able to have a show at each of the elementary campuses. The show is about healthy eating and lifestyle choices. Brazoria Hunger Coalition- M. Duchaney

Marilou Duchaney has been attending meetings lead by Megan Hoag from the Texas Hunger Initiative at Baylor University. The purpose has been to bring stakeholders together and share concerns about food insecurity in the community, brainstorm ideas for making an impact together and present the ideas of creating a Hunger Free Community Coalition. The group has been gathering the information needed to complete an application to join the Texas Hunger Initiative Network of Hunger Free Community Coalitions.

Mental Health & Human Trafficking Update- A. Jasso

BISD is continuing mental health services at five campuses within the district. Counseling session time frames have been moved from 3:00-5:00 to 1:00-3:00 as a more convenient time for students and parents. All appointment times are filled every week.

A.Jasso is the BISD representative for Unbound United Front Coalition which is looking at county wide human trafficking training. The Coalition is looking at "how we can best get the word out to public entities". B. Chambers with the Brazoria County Sheriff's office is working with the Texas Rangers and the Department of Public Safety in the area of Human Trafficking.

Interdiction Protection for Children (IPC) is a 2 day training for professionals to learn what to look for.
